SUBJECT:	New Step Up To Quality Exemptions for Publicly Funded Child Care

#### Background

Currently, providers operating a licensed child care program can only be eligible to provide Publicly Funded Child Care (PFCC) if their program is rated through the Step Up To Quality (SUTQ) program, unless exempt. House Bill 45 of the 134<sup>th</sup> Ohio General Assembly added two new exemptions to the SUTQ participation requirement outlined in paragraph (A) of rule 5101:2-16-09 of the Ohio Administrative Code (OAC). With the implementation of House Bill 45, certain child care programs will no longer be required to be SUTQ rated to provide PFCC.

### Implementation

Effective the date of this letter, the following child care providers will no longer be required to participate in SUTQ to receive payment for PFCC services.

- Type A and type B family child care (FCC) home providers.
- Ohio Department of Job and Family Services (ODJFS) licensed child care centers and Ohio Department of Education (ODE) licensed preschool and school-age programs providing PFCC to less than 25 percent of the program's capacity.

Beginning April 6, 2023, ODJFS will begin reviewing center, preschool and school-age program's PFCC utilization to determine compliance with this exemption.

Rule 5101:2-16-09, of the OAC, is being revised to reflect these changes.

What is my payment if I choose to no longer be SUTQ rated?	Programs that withdraw from SUTQ will receive the lower payment of either: The provider's customary rate to the public; or The rate outlined in appendix A to Rule <u>5101-2-16-</u> <u>10</u> , of the OAC, for non-rated programs in the provider's county. The payment change takes place the Sunday following the day the SUTQ withdraw is effective.
How do I withdraw my program from SUTQ if I meet one of the new exemptions?	A program can withdraw from SUTQ by submitting a JFS 01556 "Request to Withdraw from Step Up To Quality" to their licensing specialist. The effective withdrawal date is the date requested on the JFS 01556 or 30 days from the signature date on the JFS 01556, whichever is later.
